2. Completed nomination papers must be delivered by hand to the Deputy Returning Officer at the offices of Cotswold District Council, Trinity Road, Cirencester, Glos, GL7 1PX on any working day (excluding bank holidays) Monday to Friday after the date of this Notice between the hours of 9.00 a.m. and 5.00 p.m. until Monday 3 April 2017 and between the hours of 9.00 a.m. and 4.00 p.m. on Tuesday 4 April 2017. **Completed nomination papers must be delivered by no later than 4.00 p.m. on Tuesday 4 April 2017.**
3. If the election is contested, a poll will take place on Thursday 4 May 2017.
4. Applications to register to vote at this election must reach the Electoral Registration Officer at the Council Offices, Trinity Road, Cirencester, Glos, GL7 1PX by midnight on Thursday 13 April 2017.
5. Applications for, amendments to, or cancellations of postal votes, and amendments to or cancellations of proxy votes, must reach the Electoral Registration Officer at the Council Offices, Trinity Road, Cirencester, Glos, GL7 1PX by 5.00 p.m. on Tuesday 18 April 2017.
6. Applications to vote by proxy at this election must reach the Electoral Registration Officer at the Council Offices, Trinity Road, Cirencester, Glos, GL7 1PX by 5.00 p.m. on Tuesday 25 April 2017.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at the Council Offices, Trinity Road, Cirencester, Glos, GL7 1PX by 5.00 p.m. on Thursday 4 May 2017. The physical incapacity must have occurred after 5.00 p.m. on Tuesday 25 April 2017; and to apply on the grounds of work/service, the person must have become aware after 5.00 p.m. on 25 April 2017 that they cannot go to the polling station in person.
